## IRS SS-4 Application for Employer Identification Number: Completion Instructions

The SS-4 Application for Employer Identification Number must be completed by all U.S. groups approved to become official chapters of the Honor Society of Nursing, Sigma Theta Tau International to obtain an Employer Identification Number.

The Employer Identification Number is issued by the government and is usually required to file federal reports, open bank accounts, apply for tax exemption status with your state, and qualify for reduced postal rates through the post office.

Because the form contains personal information, please send via UPS, FedEx, or the postal service using tracking.

STTI will submit your SS4 form to the IRS on your behalf. Because we need an original signature on this form, you will need to mail the signed form.

Emailed and faxed copies of the SS4 Form will not be accepted for submission to the IRS.

Once your form is processed by the IRS, the IRS will send a letter with your chapter's EIN to the chapter address you list on the SS4 Form. Please be sure to save a copy of the IRS letter for chapter records upon receipt. Each officer should be given a copy of the IRS letter. The chapter should scan and save a copy of the IRS letter for the chapter's electronic files.

If the IRS letter will be received by anyone other than your chapter leaders (i.e. the school's main campus or headquarters), be sure to alert the appropriate personnel to send copies of the IRS letter to the chapter leaders upon receipt.

(Note: STTI receives a listing of chapter EINs from the IRS only once per year. STTI does <u>not</u> receive a copy of your EIN letter from the IRS. If your letter is lost or misplaced, it may take several months for you to request and receive a replacement letter from the IRS.)
